Subject: First Aid training reports – reg.

Sir,

This is in continuation of letter No. J.11011/12/22/SJ- Gujarat/1206-1208 dated 05.07.2022 wherein it was informed that the National Headquarters of St. John Ambulance (India) would not be able to entertain any proposal of the First Aid training reports from Gujarat State Centre until the office bearers are appointed as per rules. It was also informed that in order to avoid hardship to the trainees, the National Headquarters would consider and issue proficiency certificates on all those reports of First Aid training received till that date on the merit of the reports. Accordingly, the said training reports were considered and First Aid proficiency certificates for 10370 candidates were issued vide letter No.J.11011/12/22/SJ/Gujarat/181 dated 26.09.2022. However, subsequent proposals from State Centre seeking proficiency certificates for 2959 and 2759 candidates were returned by the National Headquarters vide letter No.J.11011/12/22/SJ-Gujarat/251-252 dated 24th January, 2023 and No.J.11011/12/21/SJ-Gujarat/166-167 dated 24th February, 2023 respectively.

2. It has been observed that as per NHQ letter dated 05.07.2022 proficiency certificates were issued to 10370 candidates whose examinations were held months before the issue of the letter. This, however, did not include those candidates who had given the examination well before the date of issue of the letter but got excluded, as the proposal received at NHQ after the deadline of 05.07.2022.

3. In order to avoid hardship to a number of candidates who had attended First Aid training and passed the examination at the time of issue of NHQ letter dated 05.07.2022, it has been decided to consider all those candidates, who had undergone First Aid training and examination upto 31st July, 2022 for issue of proficiency certificates on the merit of such reports.



In view of the above, all those reports of First Aid training and examination conducted and completed upto 31st July 2022, which were part of the reports returned by the National Headquarters vide letters dated 24th January, 2023 and 24th February, 2023, may be submitted to the National Headquarters for consideration, on merit.

Sir,

This is in reference to your proposals seeking First Aid proficiency certificates for around 12180 candidates forwarded to the National Headquarters vide your letters No. SJ/HQ/ACTS/22037 dated 01.12.2021, SJ/HQ/ACTS/21824 dated 15.11.2021, SJ/HQ/ACTS/22304 dated 20.12.2021, SJ/HQ/ACTS/22338 dated 20.12.2021, SJ/HQ/ACTS/22681 dated 03.02.2022, SJ/HQ/ACTS/22648 dated 20.01.2022, SJ/HQ/ACTS/23044 dated 31.03.2022, SJ/HQ/ACTS/23343 dated 09.05.2022, SJ/HQ/ACTS/23488 dated 30.05.2022 & SJ/HQ/ACTS/23480 dated 24.05.2022. These proposals are under consideration at National Headquarters.

2. As you are aware, as per orders of Hon'ble Chairman (Hon'ble Minister of Health & Family Welfare), all the State/UT Centres were asked to provide various information like details of office bearers, the process of their election, frequency of holding AGMs, Annual Income and expenditure, Audit of Accounts, etc of the State/UT Centre vide letter dated 02/09/2021 of National Headquarters (copy enclosed). The information in this regard was furnished by Gujarat State Centre after repeated reminders.


3. As per information furnished by the State Centre on election of office bearers i.e. Hony. Secretary, Hony. Joint Secretary and Hony. Treasurer, it is observed that the election of said office bearers has not been done through the due process as specified in the Constitution of Gujarat State Centre. It is also observed that the election does not have the approval of Hon'ble Governor. The election of office bearers made not in accordance with the rule and without approval of authority concerned cannot be considered as valid.

4. In view of the above, the National Headquarters of St. John Ambulance (India) will not be able to entertain any proposal of the First Aid training reports from Gujarat State Centre until the office bearers are appointed as per rules. However, in order to avoid hardship to the trainees, the National

Headquarters shall consider and issue proficiency certificates on all those reports of First Aid training received till date, on the merit of the reports.


5. Further, Indian Red Cross, Gujarat State Branch may step up their efforts to provide first aid training to avoid hardship to prospective candidates for first aid training.


