

Minutes of the National Stakeholders Review Meeting on Blood Transfusion Services (BTS)

Date: 22nd September 2026

Venue: Dr. Ambedkar International Centre, New Delhi

A National Review Meeting on Blood Transfusion Services (BTS) was held on 22 September 2026 under the Chairmanship of Additional Secretary (Public Health) & Director General, NACO, MoHFW, along-with DGHS, Additional DGHS, Secretary General IRCS, DDG NBTC, Director SBTCs, General/Branch Secretaries of IRCS from all States/UTs to review the status of Blood Transfusion Services across the country. List of participants is placed at Annexure-A.

2. At the outset, DGHS, MoHFW in his address emphasized that Blood Transfusion Services should be guided by the framework of Collection, Adequacy, Accessibility and Quality, with a focus on improving patient outcomes. Thereafter, the Chair presented a detailed performance review of States/UTs on the Key Performance Indicators (KPIs). The following points were discussed during the meeting:-

- a. During the discussions, it emerged that all blood centres across the country are not on-boarded on the ONDLS portal, the master line list Blood Centres operating across the country is not available, provision of monitoring the status of licences is also not enabled. The Chair directed CDSCO to update and share the master line list at the earliest.
- b. Regarding BBMS platform the Chair guided that the focus of BBMS should move beyond updates and towards maintaining comprehensive digital records, thereby facilitating the transition towards paperless blood banks. At the same time CDSCO was also directed to ensure BBMS real time data entry as a measure for paperless maintenance of records and provide an end-to-end view of collected blood units, including donation, transfusion and discard.
- c. During the meeting, based on feedback received from the heads of State Blood Transfusion Councils (SBTC), it was observed that in a few states, Inspectors and Joint Inspection Teams are insisting on the submission of physical hard copies of Blood Donation Records. The Chair directed that a clarification needs to be issued by CDSCO that record means any physical or electronic record.
- d. CDSCO to ensure ABDM compliance through mandatory order for donor traceability. NHA to enable a lighter version of ABDM to ensure seamless enrolment during blood donations.
- e. It was informed during the meeting that in certain states blood centres are also operating through para-military forces etc. The Chair directed NBTC to conduct an Inter-Ministerial meeting with M/o Defence, M/o Home Affairs, M/o Railway or any other Ministries to strengthen data linkages related to

licensing and operation of blood centres.

- f. NBTC to ensure that the Break free QR code of NACO should be displayed wherever blood collection camps are organized to facilitate risk assessment of the donor.
- g. In order to address systemic gaps and enhance the monitoring of Blood Transfusion Services (BTS) at the district level, the Chair informed that for effective monitoring and supervision the District AIDS Control Officer (DACO) will be designated as the Nodal Officer for BTS, with a specific mandate to strengthen coordination, monitoring, and supervision across blood centres in their districts.

In addition, the District Secretaries of the Indian Red Cross Society (IRCS) will conduct in-person visits and interactions at blood centres to assess ground-level realities, engage with district leadership such as the District Magistrate/Commissioner through regular/in-person meetings to report implementation issues, etc.

- h. Thereafter, the Secretary General held a separate follow-up meeting with attending IRCS State Secretaries to reaffirm that IRCS will provide supportive roles as the lead agency for conducting district-level Blood Centre surveys. The details of the Survey form were explained in detail so that the framework may be implemented effectively.

The meeting ended with a vote of thanks to the chair.

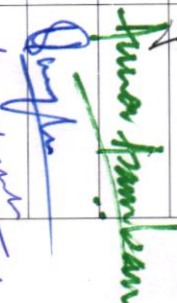
